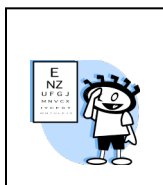

- Early Childhood Screening is paid for by the State because Minnesota wants all kids "Ready for Kindergarten".
- It tells you – "Will my child be ready for Kindergarten?"

Best done at age 3 ½ or within 90 days of public preschool enrollment

- Must be done before entering public Kindergarten. (Some private Kindergartens also require it.)
- But if you wait until Kindergarten to screen, it won't give your child time to work on skills, school routines, etc.
